I, THE UNDERSIGNED ACKNOWLEDGE THE INHERENT RISKS INVOLVED IN FLAG FOOTBALL AND ALL ACTIVITIES RELATING THERETO. ACCORDINGLY, IN CONSIDERATION OF BEING ALLOWED TO PARTICIPATE IN ANY FOOTBALL ACTIVITY AND/OR ACTIVITIES AT RMU ISLAND SPORTS CENTER, I AGREE TO THE FOLLOWING:

I ACKNOWLEDGE AND FULLY UNDERSTAND THAT I WILL BE ENGAGING IN ACTIVITIES THAT INVOLVE RISK OF SERIOUS INJURY, WHICH MAY INCLUDE PERMANENT DISABILITY AND EVEN DEATH, AND SEVERE SOCIAL AND ECONOMIC LOSSES WHICH MIGHT RESULT NOT ONLY FROM MY ACTIONS, BUT ALSO FROM THE ACTION, INACTION, OR NEGLIGENCE OF OTHERS, THE RULES OF PLAY, OR THE CONDITION OF THE PREMISES, OR ANY EQUIPMENT USED AND FURTHER THAT THERE MAY BE RISKS NOT KNOWN TO ME OR NOT REASONABLY FORESEEABLE. 2.
